# Meeting with Michael Powell, Chairman of the Federal Communications Commission, USA.

The ERG met with the Chairman of the FCC, Michael Powell. VoIP and regulatory remedies were discussed.

# **Information from the Secretary**

A proposal from the Secretary (ERG (04) 27) for deepened cooperation with the IRG secretariat was accepted by the plenary.

# **Information from the Commission**

The Commission provided information on the following.

## Follow-up of the ERG Work Programme and deliverables

The Secretary presented an update, based on the document ERG (04) 29, on the work with ERG deliverables. The Group decided to reconsider the continuation of late work items in conjunction with discussing the draft 2005 Work programme in December.

## Regulatory aspects of Voice over IP

A status report on the work on VoIP (ERG (04) 30) was presented. The subgroup was given mandate to cooperate with the Commission on a Common Position on VoIP. The Group acknowledged the topic's importance, urgency and gave it high priority.

# Wholesale international roaming (WIR)

A progress report (ERG (04) 31) on the WIR items of the Work Programme was presented. A draft market definition will be ready for the December plenary meeting. The Commission gave an overview of its statement of objections regarding the alleged abuse of dominant positions in the United Kingdom. There was agreement on the urgency of the work and that sufficient resources must be allocated.

A document describing the results of the public consultation and how they have been considered (ERG (04) 34) will also be published. The Commission will base its Recommendation on the text of the ERG Opinion. Its final Recommendation text will refer to the annex of the ERG Opinion as the relevant document setting out the practical implementation of the rules in the Recommendation, and will include a summary of the annex.
