#### **1. Opening of the meeting and adoption of the agenda**

#### **2. Information by the Chair's Secretariat**

##### **Background**

The Chair's Secretariat (i) provided information as to the Work Programme 2008 deliverables – since the last meeting no major changes have occurred with respect to the status of deliverables not affecting the outcome of this plenary, (ii) provided information as to changes in the RA PT and (iii) reported that the RSPG working group PRD, which has been approved by the RSPG group, and can now be approved as final by the ERG (after provisional approval in Vilnius).

#### **3. Next Generation Networks (BNetzA)**

##### **a) IP-IC / Next Generation Networks Regulatory Principles**

##### **Background**

BNetzA presented the draft ERG Common Position on IP-Interconnection and NGN, following consultation in respect of the NGN consultation document, and provided information as to the next steps. The consultation comments mainly concerned the separation of transport and services and charging issues.

The document (originally submitted as a CP) was approved, but as a Common Statement. Both documents were approved for publication.

**a) Mobile Termination Rates and Short Messaging Service Termination Rates benchmarking (CMT)**

**b) Remedies coordination / Benchmarking (Ofcom / CMT)**

**Background**

CMT presented a draft report on broadband prices benchmark methodologies for internal use only. The PT asked the plenary to advise if the document should be published.

BNetzA provided an oral report as to a potential reaction of the ERG to the ECTA Scorecard on regulatory effectiveness 2008. The subteam had a meeting with ECTA and Jones Day.

Ofcom provided a presentation on the VoIP action plan monitoring exercise, a draft report on the Symmetry of MTR/FTR Action Plan Monitoring and a draft report on the Broadband Common Position Conformity. At this time, we are awaiting certain answers before we publish the documentation.

**Conclusions**

The report on Broadband Prices Benchmark Methodologies was approved for publication.

The MTR/FTR Action Plan and the Broadband Common Position Conformity Report were both approved for publication. Members to provide missing data.

The Chair will approach ECTA and attempt to discuss how the ERG’s concerns can be addressed.

Feedback from 22 parties was received during the consultation process. The feedbacks resulted in two changes being made to the document. There was no need for significant changes to the report.
