Introduction and Participation

The 3rd meeting of the BEREC Contact Network (CN) for 2016 took place on **15 and 16 September 2016 in Limassol**, kindly hosted by the Cyprus <u>Office of the Commissioner of Electronic Communications and Postal Regulation</u> (OCECPR).

The meeting was attended by senior representatives of the NRAs with primary responsibility for overseeing the day-to-day operation of the markets for electronic communications networks and services. NRAs from the EU Member States, the EFTA States and the States that are candidates for accession to the EU were represented. Representatives of the European Commission also attended the meeting.
