I was part of the teams drafting 2002 and 2008 Electronic Communications Acts and associated bylaws. I also participated in the development of Croatian state aid programmes for backhaul and access network which are currently entering the building phase. I participated and had a presentations on various conferences and seminars in Croatia, mostly with regulatory or radio communications themes.
