Summary

- Adopted, revised Common Positions on Wholesale Local Access, Broadband Access, Leased Lines.
- Adopted, net Neutrality documents marking the completion of 3 years work.
- Received Commission draft Recommendation on non-discrimination and costing methodologies.
- Adopted Work Program 2013.
- Elected BEREC Chair 2014 and Vice Chairs 2013.

Revised Broadband Common Positions

- Adopted revised CPs, following public consultation, on Wholesale Local Access, Broadband Access, Leased Lines.
- Aim to assist NRAs in designing effective remedies, in pursuit of the objectives of the EU regulatory framework.
- Revisions reflect the amendment of the framework and the rapid market & technological developments (NGA roll-out)
- BEREC recognises the importance of providing the market with clear, coherent and predictable regulatory signals, to enable investments in high speed broadband networks.

Revised Broadband Common Positions

- Complement NGA Recommendation.
- Are different in nature and scope to the draft Recommendation on non-discrimination and costing methodologies.
 - Are based on NRAs collective experience.
 - Cover best practices in access, transparency, migration, pricing, and non-discrimination.
 - Do not address detailed costing issues.
- Will inform BEREC's opinion on the draft Recommendation on non-discrimination and costing methodologies.

Draft Recommendation on non-discrimination and costing methodologies

- Extensive discussion with VP Kroes and cabinet in Extraordinary Plenary on 15/11 in Brussels.
- Formal request for BEREC opinion.
- Will be provided by first Plenary 2013 (7-8 March).

Net Neutrality

- Completed three years of work on the subject of net neutrality.
- Adopted three new reports, following public consultation:
 - Assessment of IP-interconnection in the context of NN;
 - Guidelines for quality of service in the scope of NN;
 - Report on differentiation practices and related competition issues in the scope of NN.
- Adopted two high-level summaries of BEREC's positions and approaches on NN.
- Adopted BEREC response to the EC public consultation on specific aspects of transparency, traffic management and switching in an open internet.

Net Neutrality: The next steps

- BEREC is committed to the open Internet.
- Our way forward: Seek to further elaborate on Net Neutrality issues and participate in the policy debate:
 - Opinion on draft Recommendation on NN.
 - Report on platforms for measuring the Quality of broadband access services.
 - Study on consumer incentives and market forces driving NN developments.
 - Follow up on BEREC transparency guidelines.
 - Preparation for Traffic Management Investigation (round 2).

 - Implementing Roaming Regulation III, with emphasis on structural measures, Benchmarking, Machine-2-Machine services, Opinion on draft Recommendation on Relevant Markets
