

PRIVACY NOTICE

for processing of personal data in the context of BEREC and BEREC Office photo galleries

The Agency for Support for the Body of European Regulators for Electronic Communications (BEREC Office) processes the personal data of a natural person in compliance with Regulation 2018/1725 on the protection of natural persons with regard to the processing of personal data by the Union institutions, bodies, offices and agencies and on the free movement of such data, and repealing Regulation (EC) No 45/2001 and Decision No 1247/2002/EC.

This privacy notice explains BEREC Office's policies and practices regarding its collection and use of your personal data, and sets forth your privacy rights. We recognise that information privacy is an ongoing responsibility, and we will update this notice where necessary.

1. What is the purpose and legal basis for processing your personal data?

There are 2 specific purposes of processing of photos taken at different BEREC and the BEREC Office internal and external events.

- 1) Strengthening the corporate identity – to provide BEREC Office staff members with high quality photos, for the professional or private use.
- 2) Establishment of the photo gallery of BEREC and the BEREC Office. The photos are to be used for internal and external communication activities of BEREC and the BEREC Office in order to promote the organization, ensure its transparency and credibility as well as to maintain its corporate identity. The photos might be published on the BEREC website, its social media accounts or other internal and external information materials. Photos might be used also for the “face book” of the BEREC Office staff members for the BEREC Chair's Office needs, for the BEREC Office staff professional accounts on social media and similar.

As the BEREC Office collects and further processes personal data, it is subject to Regulation (EU) 2018/1725 of the European Parliament and of the Council of 23 October 2018 on the protection of individuals with regard to the processing of personal data by the Union institutions, bodies, offices and agencies and on the free movement of such data.

The current processing operation is based on Article 5(1)(d) of Regulation 2018/1725 i.e. the data are collected based on the consent of the data subjects.

2. What personal data is collected and processed?

BEREC Office is collecting and processing as personal data photos of people who participates at BEREC and the BEREC Office internal and external events, such as workshops, stakeholders meetings, Stakeholder Forum, public debriefings, team building and other events and occasions, photo sessions of the employees of the organisation, including staff members, trainees and external service providers.

Along with the photos, BEREC Office will collect and further process the following information:

- Name;
- Surname;
- Position in organisation;
- Signature.

3. Who has access to your personal data and to whom is it disclosed?

The personal data will be accessed only by the BEREC Office employees in charge of communications activities and the event management company assisting the BEREC Office in organising external and internal events.

4. How long are your personal data kept?

Personal data collected are kept by the BEREC Office until the data subjects request to remove the photos from the BEREC Office internal server.

5. What are your rights?

You have the right to request from the controller access to and rectification or erasure of your personal data or restriction of processing.

You also have the right to data portability.

Finally, you also have the right to withdraw your consent for BEREC Office to process your personal data at any time.

The controller shall provide information on action taken on a request within one month of receipt of the request. That period may be extended by two further months where necessary, taking into account the complexity and number of the requests.

6. Who is the data controller and how to exercise your rights?

The BEREC Office shall exercise the tasks of the data controller for the purpose of these processing operations.
