

DECISION № BoR/2012/1

of the Board of Regulators on BEREC Expert Working Groups

The Board of Regulators,

HAVING REGARD TO Regulation n. 1211/2009 of the European Parliament and of the Council of 25 November 2009 establishing the Body of European Regulators for Electronic Communications (BEREC) and the Office (BEREC Regulation) and, in particular, article 6.2 thereof:

HAVING REGARD TO the "Rules of Procedure of the Board of Regulators" (document BoR (11) 23) and, in particular, Article 11 - which states that "the Board of Regulators may decide to create Expert Working Groups to assist with the performance of the tasks and functions of BEREC and request the Office to provide support. The Chair of the Expert Working Group shall be designated by the Board of Regulators. Expert Working Groups shall be open to all members and observers.";

Has adopted the following Decision:

Article 1 – Objective and scope

The purpose of this decision is to confirm the BEREC Expert Working Groups, which have been created in accordance with article 11 of the Rules of Procedure of the Board of Regulators, and to designate the Chairs for each Expert Working Group for 2012.

In accordance with article 6.2 of the BEREC Regulation, the BEREC Office is requested to set up the Expert Working Groups and provide professional and administrative support to them.

Article 2 – BEREC expert working groups
