## ERG 2009 TIMETABLE FOR MONITORING OF CONFORMITY WITH ERG CPs

In the report published at the beginning of 2008 by ERG (Monitoring of conformity with ERG Common Positions: lessons learned from broadband questionnaires and next steps **EERG** (08) 06), ERG committed itself to:

bublish a timetable for the conduct of future monitoring exercises covering a wider range of ERG Common Positions+

ERG has now updated<sup>1</sup> the timetable for 2009. This covers two distinct types of activity:

- A *Monitoring Exercise*+is conducted to establish the extent of conformity of national regulatory regimes with the relevant ERG Common Position. In reporting on future exercises of this type, ERG expects to publish an assessment of conformity in each country, in addition to an overall assessment. The results may also indicate a necessity to update the underlying Common Position.
- %n Action Plan+is an exercise to identify individual NRA plans to bring national regulation into line with the relevant ERG Common Position.

The time table will be updated from time to time (this is the 1<sup>st</sup> update).

For the monitoring exercises, ERG believes it would be most useful to carry out the assessments once the bulk of NRAs have completed their next round of Market Reviews. As expected the first half of 2009 lends itself to the exercise.
