Main results from the Meeting of the Board of Regulators (BoR) of BEREC

1. Approval of the BEREC Medium Term Strategy Outlook

The BoR approved the BEREC Medium Term Strategy Outlook for publication and implementation, according to which BEREC's main focus will be further contributing to the realisation of the internal market through delivering results that matter. The BoR approved for publication also the report on the results from the public consultation on the draft Strategy.

2. Approval of the analysis of the wholesale roaming costs

With a view to supporting the legislative process on the Roaming Regulation III, the BoR approved updated assessment of the wholesale roaming costs to be submitted to the Council, European Parliament and the Commission.

3. Review of the Common Positions (CPs) on key wholesale access products

As a first stage in BEREC's update of the ERG CPs on wholesale unbundled access, wholesale broadband access and wholesale leased lines, the BoR agreed to publish a consultation on high level principles of non-discrimination. The consultation will be held in the period 1 March - 30 March 2012.

4. Traffic Management Investigation

The BoR approved the preliminary results from the traffic management investigation and agreed on the next steps with a view to preparing a complete snapshot of the existing practices, which will be published in mid-April 2012. In the meantime the work on verifying the results will continue.

5. Approval of Reports

The BoR approved the following reports:

5.1. BEREC Broadband Promotion Report and the report on the outcome from the subsequent public consultation. Both, the reports and the responses will be published.

5.2. BEREC-RSPG Report on economic and social value of radio spectrum

The BoR approved also the draft Report on exploring the economic and social value of radio spectrum for certain electronic communications services with respect to the frequency assignment procedures, prepared jointly by BEREC and RSPG. The report will be published after its approval by RSPG.

Introduction

The BoR of BEREC held its 10th meeting on 23 and 24 February 2012, in Vienna, kindly hosted by the Austrian Regulatory Authority for Broadcasting and Telecommunications - RTR-GmbH.

The meeting was attended by high-level representatives of the National Regulatory Authorities (NRAs) established in each EU Member State, EFTA States and those States that are candidates for accession to the EU with primary responsibility for overseeing the day-to-day operation of the markets for electronic communications networks and services. The Commission also took part in the meeting and was also represented at high level.

The Chair provided an oral up-date on the BEREC communication activities and significant meetings conducted since the last plenary meeting. The Chair participated in a number of events, including meetings with the stakeholders and a public hearing on roaming organised by the group of the European People's Party (EPP) of the European Parliament.

The BEREC Chair had a bilateral meeting with the Vice-president of the European Commission and Commissioner for digital agenda – Mrs Neelie Kroes, during which both sides discussed the BEREC priorities for 2012.

The BEREC Chair also visited the BEREC Office in Riga and had a meeting with the BEREC Office staff on the priorities and the method of work for the current year. These meetings will continue on a regular basis.

The BoR discussed the draft and approved it for public consultation, which will take place in March 2012. BEREC will also organise a workshop with the stakeholders in the middle of the consultation period.

7. Net Neutrality

- Summary of the results from the traffic management investigation

Information presented

ARCEP, co-chairing the Net Neutrality EWG, presented summary of the results from the traffic management investigation, held in December 2011 and January 2012¹. ARCEP presented also different options for the next steps to be undertaken in that field with a view to improving the quality of data.

The BoR took note of the preliminary results from the traffic management investigation and requested the traffic management investigation team to continue its work with a view to further verifying and analysing the data. The BoR asked the team to prepare a complete snapshot of the existing practices, which will be published in mid-April 2012 and presented to the Commission.

Conclusions

The BoR took note of the results and agreed on the next steps with a view to preparing a complete snapshot of the existing practices for submission to the Commission and for publication in mid-April 2012.

The International Roaming EWG Chair (Ofcom) presented the state of play on the draft Roaming Regulation III and the draft estimates of wholesale roaming costs, prepared following a request from the European Commission to BEREC to inform the European Parliament and Council on the levels of wholesale caps for voice and data roaming.

Conclusions

The BoR discussed and approved the estimates of wholesale roaming costs to be submitted to the Council, European Parliament and the Commission. BEREC estimates that by 2014 the cost of wholesale voice roaming is likely to be below 5c/min, the wholesale cost of data roaming is likely to be below 5c/MB, and the cost of wholesale SMS roaming is likely to be below 1c/SMS

11. BEREC-RSPG Cooperation
