## 4. BEREC Office Multi-annual Staff Policy Plan for 2013-2015

Draft BEREC Office Multi-annual Staff Policy Plan for 2013-2015

### Information presented

The AM presented a draft Multi-annual Staff Policy Plan (MSPP) for 2013-2015, which should be sent to the Commission Services for preliminary consultation in January 2012.

It was pointed out that the draft had been prepared on the basis of the old form due to the delay in the distribution of the new form by DG HR. In that respect the AM stated that the draft might need some technical adjustments afterwards if there would be a new form.

Furthermore the MC expressed its desire to further improve the quality if the BEREC documents and in that respect emphasised the need for additional support to be provided by the Office to the EWGs, in particular as far as the usage of the English language was concerned.

In that respect the Office was asked to further study the options for providing support to the EWGs in improving the quality of BEREC papers.

#### Conclusion

The draft MSPP for 2013-2015 was approved for submission to the Commission services for preliminary consultation.

The Office was tasked to explore the possibilities for improving the quality of BEREC papers, in particular the correct usage of the English language.

#### 5. AOB

#### - Budget of the BEREC Office for 2012

The AM informed the MC that the Budgetary Authority had reduced the BEREC Office budget for 2012 with 1% from the Budget approved by the MC, which would require revision of the Budget.
