Management Committee Meeting

- BEREC Office in own office since first week September
- BEREC Office autonomy granted mid September
- Further recruitment decisions; BEREC Office staff to be 21 end 2011.
- Support by BEREC Office important for the BoR
- Official opening of BEREC Office in Riga on October 14th



Next generation networks Revision of state aid guidelines

- NRAs role: advise on policy decisions in member states.
- Issue of legal basis and inconsistent approach NRA role.
- Subsidised networks: future proof and pro competitive.
- Stagnant demand side for broadband take up.
- Issue of proportionality.
- Prolongation of measures after 7 year.



Next generation networks Implementation of NGA recommendation

- BEREC's analysis based on the ladder of investment.
- Regulatory certainty and consistency essential.
- Conformity check still showing different stages of NGA roll out and deployment.
- In 2012 BEREC aims for definite best practices.



Net neutrality and transparency

- Informed end users plus easy switching is a key.
- Several ways to convey information: tiered approach, visual representation, real time information tools, various levels of detail depending on user type.
- Roles for NRAs and European initiatives
- Consultation until 2 November 2011
- Submit responses to BEREC Office

Benchmarking reports

- Two benchmark reports approved, MTR and SMS TR.
- MTR continuous decrease: last year 25%.
- On average 9,7% annual decrease of MTR since 2004
- SMS TR report is a new quarterly report.
- First findings: average wholesale price of 3,33 €cents.



Cost accounting in practice

- Annual report on methodologies.
- Stable picture with clear preferences:
 - Price control through cost orientation w/o price cap.
 - Cost base CCA
 - Accounting methodologies LRIC/FDC
- High degree of harmonisation.
- Developing effective RA frameworks for NRAs.



International roaming report

- Broad picture in line with previous reports.
- Average unregulated prices for voice calls made and SMS higher than average Eurotariffs
- Average unregulated prices for voice calls received fell below Eurotariff
- Average wholesale and retail data roaming prices lower, now well below regulated caps.
- Still a significant margin for off net retail data roaming.



BEREC's Work Programme 2012

- Aim for harmonisation remains priority.
- Important issues: NGA, NN, IR, BEREC opinions on new recommendations and US obligation, article 7 cases
- Additional focus on consumer empowerment.
- Consultation period until 3 November 2011
- Submit responses to BEREC Office
