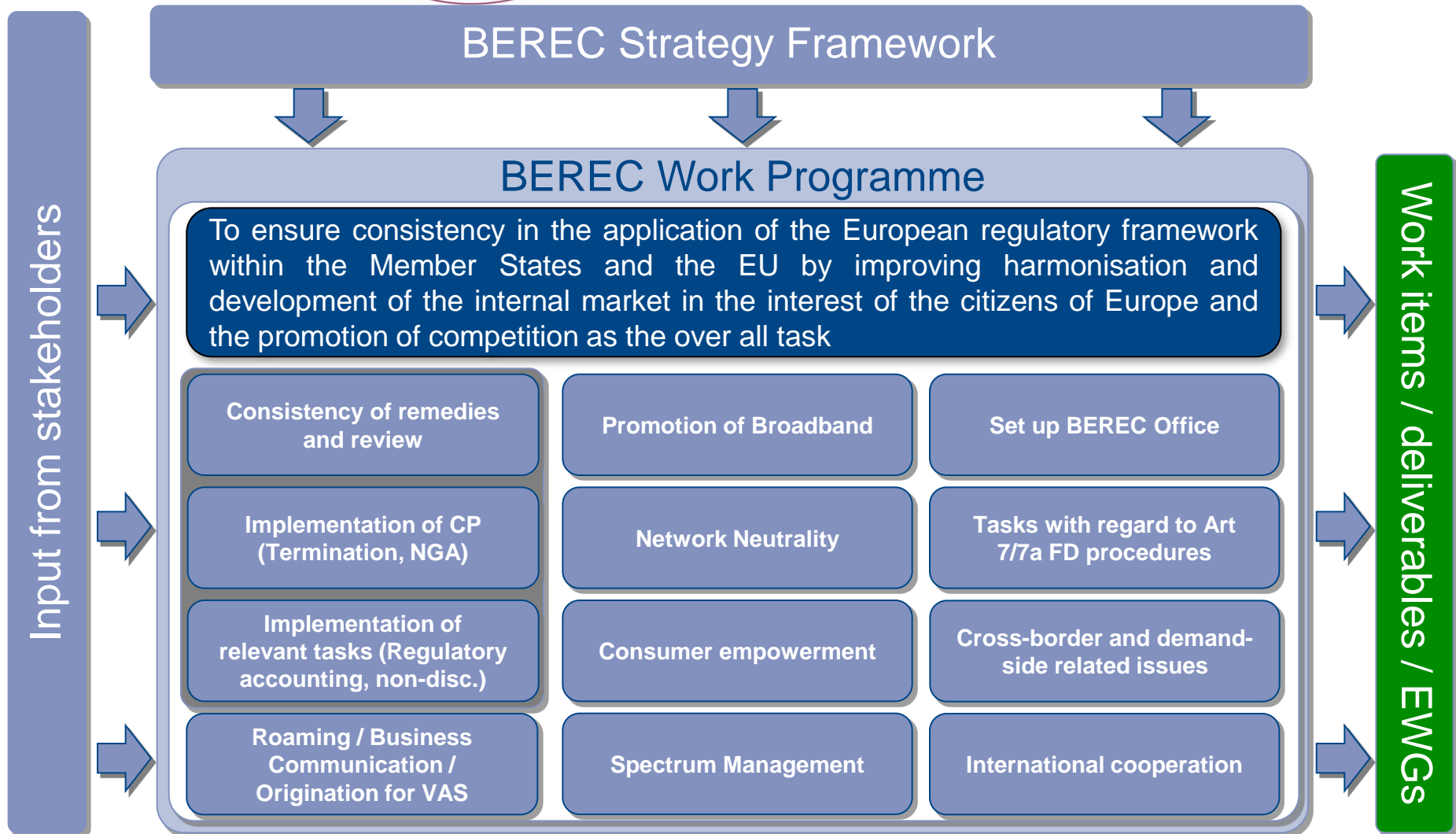

Basic principles and assumptions

- The 2011 WP was set up as a multiannual WP
- The draft of the 2012 WP continues the established approach
- Nevertheless since BEREC made reasonable progress this year, that has to be taken into account for the next WP
- The structure is based on the different roles of BEREC set out in the BEREC Regulation rather than the three work streams of 2011

BEREC has to fulfil different roles

- According to Art. 2 of BEREC Regulation there are two types of stakeholders:
 - Political stakeholders (EC, EP, Council, NRAs, nat. politics) and
 - the market and the environment
- BEREC therefore shall develop best practices,
 - Common approaches, methodologies or guidelines on implementation
- provides assistance to NRAs (on request),
- delivers opinions on draft decisions, recommendations and guidelines of the EC,
- issues reports (“monitoring of the market”) and provides advice, delivers opinions to the EP and the Council and
- assists the EP, the Council, the EC and NRAs in relations, discussions and exchanges with third parties
