

Decision MB/2025/08
of the Management Board of the Agency for Support for BEREC for applying
by analogy of Decision C(2025) 2495 final of 13 May 2025 on the general
provisions for implementing Articles 11, 12 and 13 of Annex VII to the Staff
Regulations of Officials and on authorised travel

The Management Board,

Having regard to the Treaty on the Functioning of the European Union,

Having regard to the Staff Regulations of Officials and the Conditions of Employment of Other Servants of the European Union, laid down in Regulation (EEC, Euratom, ECSC) No 259/68¹, and in particular Article 110(2),

Having regard to Regulation (EU) 2018/1971 of the European Parliament and of the Council of 11 December 2018 establishing the Body of European Regulators for Electronic Communications (BEREC) and the Agency for Support for BEREC ('BEREC Office'), amending Regulation (EU) 2015/2120 and repealing Regulation (EC) No 1211/2009², and in particular Article 16 (j),

Having regard to the Rules of Procedures of the Management Board of the BEREC Office and in particular Article 2 thereof,

Having regard to Commission Decision C(2025) 2495 final³ of 13 May 2025 on the general provisions for implementing Articles 11, 12 and 13 of Annex VII to the Staff Regulations of Officials and authorised travel,

After consulting the Staff Committee⁴,

Whereas:

- (1) On 13 May 2025 the European Commission adopted Decision C(2025) 2495 final of 13 May 2025 on the general provisions for implementing Articles 11, 12 and 13 of Annex VII to the Staff Regulations of Officials and on authorised travel, which was notified to the BEREC Office in accordance with the procedure of Article 110(2) of the

Staff Regulations on 14 May 2025. This Decision entered into force in the Commission on the date of its adoption on 13 May 2025.

- (2) The Decision mentioned above contains the revised Guide to Missions and authorised travel, putting forward a number of novelties concerning the simplification and update of procedures, additional provision on greening and ethical principles, as well as updated financial conditions for the missions of staff.
- (3) In line with the Staff Regulations, the Commission staff implementing rules apply by analogy to agencies. These take effect at the agencies nine months after entering into force at the Commission or after the Commission notifies the agencies, whichever is later. Nevertheless, the agency may decide that such implementing rules are to enter into force at an earlier date.
- (4) At the moment of the notification the BEREC Office was applying Commission C(2017) 5323 of 27 September 2017 on the general provisions for implementing Articles 11, 12 and 13 of Annex VII to the Staff Regulations of Officials (mission expenses) and on authorised travel.
- (5) For the management of the missions to staff the BEREC Office uses the Commission corporate tool MiPS+ and according to the conditions of its use the BEREC Office has undertaken to apply by analogy the Commission missions' rules as of the same date as the Commission. In addition, MiPS+ has been configured based on the applicability of Commission Decision C(2025) 2495 as of 13 May 2025.
- (6) In line with the procedure envisaged in Article 110 of the Staff Regulations, the BEREC Office Staff Committee was consulted and gave favourable⁵ opinion on the implementation of Decision C(2025) 2495 final of 13 May 2025 by analogy.
- (7) Therefore, Decision C(2025) 2495 final of 13 May 2025 on the general provisions for implementing Articles 11, 12 and 13 of Annex VII to the Staff Regulations of Officials and on authorised travel should apply at the BEREC Office as of 13 May 2025 and Decision C(2017) 5323 should not apply to the BEREC Office by analogy anymore.

Has adopted the following decision:

Article 1

Application by analogy

Commission Decision C(2025) 2495 final of 13 May 2025 on the general provisions for implementing Articles 11, 12 and 13 of Annex VII to the Staff Regulations of Officials and authorised travel shall apply to the BEREC Office by analogy.

Article 2

Repeal and consequences of repeal

Commission Decision C(2017) 5323 final shall not apply by analogy to the BEREC Office anymore.

Article 3

Entry into force

This Decision shall take effect on 13 May 2025.
