

Decision No. MB/2025/11
of the Management Board of the Agency for Support for
BEREC (the BEREC Office) on the appointment of two
Members of the BEREC Office Advisory Group for a third term

The Management Board,

Having regard to Regulation (EU) 2018/1971 of the European Parliament and of the Council of 11 December 2018 establishing the Body of European Regulators for Electronic Communications (BEREC) and the Agency for Support for BEREC (BEREC Office), amending Regulation (EU) 2015/2120 and repealing Regulation (EC) No 1211/2009¹, and in particular Article 16 thereof,

Having regard to the Rules of Procedure of the Management Board of the BEREC Office², and in particular Articles 1(6), 3, 10 and 16 thereof,

Having regard to the Rules of Procedure of the BEREC Office Advisory Group³ annexed to the Rules of Procedure of the Management Board of the BEREC Office, and in particular points 3 (1) and 4 (2) thereof,

Having regard to the Decision of the Management Board of the BEREC Office on the Establishment of the BEREC Office Advisory Group and on the Appointment of its Chair⁴,

Whereas,

- (1) The term of the current BEREC Office Advisory Group (BAG) members will conclude at the end of 2025.
- (2) In accordance with the BAG's composition, the group must include at least six members, including the Deputy Chairperson (incoming Chairperson), a representative of the Chairperson, and a representative of the European Commission.

- (3) A call for nominations for the new BAG was launched with a deadline of 17 October 2025. Following the extension of the deadline, an insufficient number of candidates to establish the new BAG was received.
- (4) In light of the need to ensure continuity in the work of the BAG, and the absence of new nominations, it was decided to exceptionally accept applications from current BAG members who have already served two terms.
- (5) This decision constitutes a derogation from the current Rules of Procedure, which stipulate that BAG members may serve a term of three years, renewable once.
- (6) The Management Board therefore agrees to exceptionally extend the term of two current BAG members for a third term.

Has decided the following:

Article 1

Appointment of BAG Members for a Third Term

1. Ms. Annegret Groebel (BnetzA) and Mr. Georgios Charokopakis (EETT) are hereby appointed as members of the BEREC Office Advisory Group for a third term.
2. Their term shall commence on 1 January 2026 and conclude on 31 December 2028.

Article 2

Entry into force and communication

1. This Decision shall enter into force on the date of its adoption.
2. It shall be published on the Agency's website and communicated to persons concerned by the BEREC Office.
