## Main Results from the 11<sup>th</sup> meeting of the Board of Regulators (BoR)

#### I. Net Neutrality (NN)

NN was the central topic of discussion during the 11<sup>th</sup> BoR meeting.

The BoR approved for publication the Snapshot from the traffic management investigation and agreed to opening of public consultation on the following draft documents:

- Draft BEREC Report on differentiation practices and related competition issues in the scope of NN;
- Draft BEREC Guidelines for Quality of Service (QoS) in the scope of NN;
- Draft BEREC Report "An assessment of IP-interconnection in the context of NN"

The draft documents will be published for public consultation immediately after the plenary for a period of 8 weeks.

#### II. Final documents approved by BoR

## The BoR approved the following BEREC reports for publication:

- Report on the impact of fixed-mobile substitution (FMS) in market definition and the consultation report;
- Report on Special Rate Services (SRS) and the consultation report;
- Report on co-investment and significant market power (SMP) in next generation access (NGA) networks and the consultation report;
- Report on the current accessibility of numbering resources pursuant to Article 28.1 of the Universal Service Directive (USD);
- Termination Rates Integrated Snapshot as of January 2012;
- 2011 BEREC Annual Report (2011 BEREC activities and developments of the eCommunications sector).

## III. Other important topics discussed

The BoR agreed to accept the offer of IRG to host BEREC's presence in Brussels free of charge.

The BoR discussed also the draft BEREC 2013 Work Programme (WP), the practical and strategic next steps in building BEREC's future and BEREC's approach to fulfilling its obligations under the revised Roaming Regulation.

The meeting was attended by high-level representatives of the National Regulatory Authorities (NRAs) established in each EU Member State, EFTA States and the States that are candidates for accession to the EU with primary responsibility for overseeing the day-to-day operation of the markets for electronic communications networks and services. The Commission also took part in the meeting and was also represented at high level.
