

**DECISION № MC/2012/1**

**by the Management Committee of the Office of the Body of European Regulators for  
Electronic Communications (BEREC) on the adoption of implementing rules to the  
staff regulations**

**The Management Committee of the BEREC Office,**

Having regard to the Staff Regulations of Officials and Conditions of Employment of Other Servants of the European Union, laid down by Council Regulation (EEC, EURATOM, ECSC) No 259/68, and in particular to Article 110 of the Staff Regulations.

Having regard to the Regulation (EC) № 1211/2009 of the European Parliament and of the Council of 25 November 2009 establishing BEREC and the Office, and in particular article 10 thereof.

Having regard to the decisions of the Commission setting up implementing rules for the application of the Staff Regulations of officials and the Conditions of Employment of other servants of the European Union.

In agreement with the European Commission pursuant to Article 110 of the Staff Regulations<sup>1</sup>.

The Staff Committee of the BEREC Office, which is to be consulted pursuant to Article 110, paragraph 1, second sentence, of the Staff Regulations, has not yet been constituted and it is therefore impossible at the present to comply with the requirements of that provision. The Staff Committee will be invited to give its opinion on the relevant implementing rules when it has been constituted and due consideration will be given to any such opinion. The Management Committee is entitled in such circumstances to approve the rules forthwith.

**Has adopted the following general implementing rules:**

**Article 1**

The general implementing rules of the Staff Regulations, as adopted by the Commission, and listed in Annex I, shall apply by analogy to the staff of the BEREC Office.

**Article 2**

This decision shall take effect on the day following that of its adoption, except the Commission decision on introducing implementing provisions on leave (C(2010) 7495 of 05.11.2010), which will take effect as of 1 January 2012.
