# **BEREC mid term strategy**

Approach:

B

- adopting common regulatory approaches
- issuing robust and respected opinions on Art.7 cases
- advising EU-institutions on draft legislation and regulation
- Main themes:
  - Infrastructural developments: Next generation networks, access policy
  - Consumer empowerment: boosting choice and protection (privacy, security)
  - Service related developments: i.e., continued work on International roaming, special rate services, cross border services – all of these contribute to enhance competition, development of internal market

#### Net neutrality and transparency

- Report from the public consultations (77 contributions)
- Guidelines on transparency: a tool to enhance end users' possibility
- to make informed choices among service offers
- relevant requirements for transparency practices:
  - accessibility, understandability, meaningfulness, comparability and accuracy
- recommended:

- general information about the service, general limitations of the service and specific limitations of the service
- bandwidth of offer and need for clear information about actual speed



# **Net Neutrality and QoS**

- Report on framework for quality of service in relation to net neutrality, elaborating quality related concepts and quality evaluation methods
- aim of imposing minimum quality requirements is to prevent degradation of service
- Need for continued work identified: 2012 work stream on "Guidelines on Quality of Service in the scope of Net Neutrality"




#### **Report on Fixed-mobile substitution**

- considers the impact of fixed-mobile substitution (FMS) both in voice and broadband services, in market definition and the main concepts relevant for this assessment
- to provide guidance on the information to be used by NRAs to analyze a possible integration of fixed and mobile services in the same market; and
- to present a generic analysis on the potential impact of FMS on traditional fixed markets failures



# **Promotion of Broadband**

- to analyze the role of regulatory mechanisms/tools at EU, national, regional and local level for promoting broadband
- Interdependency between different promoting mechanisms
- advise public policy makers on their role in BB-promotion
- the report underscores a mix of reducing the cost of access and increasing perceived value of broadband services



#### **Special rate services**

- Guidance for NRAs on the regulation of Special Rate Services (SRS)
- SRS are defined as usage based services
- Characteristics of SRS in the EU, problematic features and negative effects for consumers
- Report to be published for consultation

#### **Competitive effects of NGA-co investments**

- Report suggests elements, criteria to examine for effective competition and SMP-designation in co-investment scenario, markets 4 and 5
- NGA reco: market analysis not only number of operators but also structure of network and co-investment arrangements to be considered
- Co-investments lead to effective competition if sufficient independence of the partners is warranted
- Analysis on impact to retail market to be performed before change of wholesale regulation
- Report to be published for consultation
