<i>Information presented</i>	EETT presented an overview on the revised draft 2013 BEREC WP following the public consultation and the public hearing on the draft and the outcome from the PC. There was a consistent, strong participation from the market, on the contrary a lack of awareness by user groups and consumer associations. As a matter of fact, BEREC received the contributions mainly from operators; on the contrary not so many consumers association participated. Contributors expressed a strong wish for continuing and increasing engagement. In general, there were requirements for more public consultations and for strengthening the dialogue with the stakeholders. Furthermore, there were comments asking BEREC to suggest new markets in the Commission recommendation on relevant markets. Moreover, there were several proposals for additional projects, for example for a review of 2007 ERG Common Position on VoIP and for a review numbering practices to address market developments.

<i>Information presented</i>	<p>The Remedies and NGN EWGs' Chairs (Ofcom and BNetzA) presented the revised BEREC CPs on WLA, WBA and WLL following the PC held in the period 28 Sept. – 18 Oct. 2012. The presentation included an overview of the results from the PC: 12 responses received. Firstly the EWGs' Chairs recalled that the BEREC CPs have been based on best practice remedies (BPs) in markets 4/5/6 and on the collective experience of NRAs themselves, with the aim, among all, to contribute to consistency and quality of remedies and to allow adequate flexibility for NRAs to reflect specific national market circumstances. As shown by the result of the public consultation, most stakeholders agreed with BEREC's proposed principles, though with different views on the level of prescription.</p>
<i>Conclusions</i>	BoR approved the CPs for publication and application.
