

## **DECISION № MC/2014/10**

### **of the Management Committee of the Office of the Body of European Regulators for Electronic Communications (BEREC Office) to approve the proposals for the appointment of a Programme Manager and the establishment of a reserve list (TA – Grade AD5) of the BEREC Office**

#### **The Management Committee of BEREC Office,**

HAVING REGARD to the Staff Regulations of Officials of the European Union and the Conditions of Employment of Other Servants of the European Union laid down by Council Regulation (EEC, Euratom, ECSC) No 259/68 and the amendments thereto, and in particular Articles 43 and 110 of the Staff Regulations, and Articles 15(2) and 87(1) of the Conditions of Employment of Other Servants;

HAVING REGARD to Regulation (EC) No 1211/2009 of 25 November 2009 of the European Parliament and of the Council establishing the Body of European Regulators for Electronic Communications (BEREC) and the Office (hereinafter "Office"), and in particular Articles 7 and 10 thereof;

HAVING REGARD to the Decision by the Management Committee of the BEREC Office on the general implementing provisions on the procedures governing the engagement and the use of Temporary agents at the BEREC Office (MC (10) 23); and in particular Article 3 (3) and Article 3 (6) thereof.

Whereas the Selection Committee appointed for the recruitment of the Programme Manager was composed by the listed members:

- Mr Michele CHIODI – Legal Officer, Administration & Finance Unit, and Chair of the Selection Committee;
- Mr Laszlo KASA – Senior Programme Manager, Programme Management Unit;
- Mr Antonio MANGANELLI – Programme Manager, acting as Staff Committee representative of the BEREC Office.

Whereas the appointed Selection Committee agreed on a report on 14 July 2014;

Whereas the Selection Committee suggested the appointment of:

Mr Slawomir Briska as successful candidate for the post of Programme Manager;

Whereas the Selection Committee suggested to create a reserve list of three candidates in order of merit for the post of Programme Manager of grade AD5;

#### **HAS ADOPTED THE FOLLOWING DECISION:**

To approve all proposals suggested by the Selection Committee and agree that the Vice Chair appoints the Programme Manager and adopts the reserve list.

The reserve list shall be included in an Annex to the Decision of the Vice Chair of appointment.

The reserve list shall be adopted in order of merit and with validity 12 months from the date of its establishment. Its validity may be extended by Decision of the Vice-Chair of the Management Committee prior to its expiration.

The present decision shall enter into force on the day of its adoption.
