

Decision № MC/2015/11

of the Management Committee of the Office of the Body of European Regulators for Electronic Communications (BEREC Office) to approve the proposals for the establishment of reserve lists for the posts of Legal Officer (TA – Grade AD5) and Executive Support Officer (TA – Grade AD5) of the BEREC Office

The Management Committee of BEREC Office,

HAVING REGARD to the Staff Regulations of Officials of the European Union and the Conditions of Employment of Other Servants of the European Union laid down by Council Regulation (EEC, Euratom, ECSC) No 259/68 and the amendments thereto, and in particular Article 2(f) of the Conditions of Employment of Other Servants,

HAVING REGARD to Regulation (EC) No 1211/2009 of 25 November 2009 of the European Parliament and of the Council establishing the Body of European Regulators for Electronic Communications (BEREC) and the Office (hereinafter "Office"), and in particular Articles 7 and 10 thereof,

HAVING REGARD to the Decision of the Management Committee of the Office of the Body of European Regulators for Electronic Communications (BEREC Office) MC/2015/03 on laying down general implementing provisions on the procedure governing the engagement and use of temporary staff under Article 2(f) of the Conditions of Employment of Other Servants of the European Union,

- 1) Whereas the Selection Committee appointed under procedure BEREC/2014/08 for the establishment of a reserve list for the post of Legal Officer (TA-AD5), and composed of the following members:
 - Ms Véronique BAGGE Head of Administration and Finance Unit, and Chair of the Selection Committee:
 - Mr Michele CHIODI Legal Officer, Administration and Finance Unit;
 - Mr Fabrice ANDREONE Staff Committee representative;

Agreed on a report on 08 July 2015 to propose the creation of a reserve list of three candidates in order of merit;

- 2) Whereas the Selection Committee appointed under procedure BEREC/2014/06 for the establishment of a reserve list for the post of Executive Support Officer (TA-AD5), and composed of the following members:
 - Mr László IGNÉCZI Administrative Manager and Chair of the Selection Committee;



- Ms Véronique BAGGE Head of Administration and Finance Unit (alternate: Mr Pablo AGUIRREZABAL JAUREGUI, Human Resources Officer);
- Mr Fabrice ANDREONE Staff Committee representative;

Agreed on a report on 02 September 2015 to propose the creation of a reserve list of eight candidates in order of merit;

HAS ADOPTED THE FOLLOWING DECISION:

To approve the proposals from the Selection Committees in their reports of 8 July 2015 and 2 September 2015 and agree that the Vice-Chair shall establish the reserve lists.

The reserve lists shall be adopted by the Vice-Chair in order of merit and with validity 12 months from the date of their establishment. Their validity may be extended by Decision of the Vice-Chair of the Management Committee prior to their expiration.

This decision shall enter into force on the day of its signature.
