

**Decision No BoR/2016/04
of the Board of Regulators on the BEREC Expert Working Groups**

The Board of Regulators,

HAVING REGARD TO Regulation No 1211/2009 of the European Parliament and of the Council of 25 November 2009 establishing the Body of European Regulators for Electronic Communications (BEREC) and the Office¹ (BEREC Regulation) and, in particular Article 4 (7) thereof;

HAVING REGARD TO the Rules of Procedure of the Board of Regulators² and, in particular Article 11(1) thereof;

HAVING REGARD TO the Decision BoR/2014/3 that creates the BEREC Expert Working Groups and appoints their almost all their co-Chairs;

HAVING REGARD TO the Decision BoR/2015/1 that appoints the Co-Chairs of Expert Working Groups;

Whereas,

- 1) The work of BEREC may be organised into Expert Working Groups;
- 2) The Board of Regulators should appoint the Co-Chairs of each Expert Working Group for the implementation of the BEREC Work Programme;
- 3) Each Expert Working Group shall be led by two co-Chairs, from different NRAs, unless in exceptional and temporary circumstances;
- 4) The Board of Regulators has created nine Expert Working Groups and appointed all co-Chairs with decision of December 2014, February and December 2015 respectively;
- 5) The Board of Regulators shall approve the decision that establishes the EWGs and appoints their co-Chairs for the following year before the end of each civil year.

Has adopted the following Decision:

Article 1

For the year 2017 the following BEREC Expert Working Groups are continued (as laid down in BoR/2014/3, BoR/2015/1, BoR/2015/2 and BoR/2015/3) or re-configured and the following EWG Co-Chairs are (re-)appointed:
