## Introduction and Participation

The 4<sup>th</sup> meeting of the BEREC Contact Network (CN) for 2018 took place on **15-16 November 2018 in Luxembourg**, kindly hosted by <u>Institut Luxembourgeois de Régulation</u> (ILR). The meeting was chaired by **Elisabeth Dornetshumer** – International Affairs Manager (RTR) and representative of the BEREC Chair 2018, **Johannes Gungl** – Managing director of RTR (Austria).

The meeting was attended by senior representatives of the national regulatory authorities (NRAs) with primary responsibility for overseeing the day-to-day operation of the markets for electronic communications networks and services. NRAs from the EU Member States, from the EEA countries and from the States that are candidates for accession to the EU were represented. The European Commission also attended the meeting.

## Main Results of the 4th meeting of the BEREC Contact Network in 2018

The objective of the meeting was to prepare the 37<sup>th</sup> ordinary plenary meetings of the BEREC Board of Regulators (BoR) and the BEREC Office Management Committee (MC), due to take place on 6-7 December 2018 in Prague (Czech Republic), which will be hosted by the <u>Czech Telecommunication Office</u> (CTU). Consequently, the BEREC Contact Network (CN) considered all possible topics to be included in the BoR and MC agendas and concluded the following:

The BoR will be briefed on the recent activities of the BEREC Chair, important projects carried out by the BEREC Office in support of BEREC, recent and forthcoming BEREC international activities, as well as preparations related to the entry into force of the new telecommunications regulatory framework and revised BEREC Regulation. The BoR will also share experience on NN national cases. The BoR will elect its Chair for 2020 and appoint EWG Co-Chairs for 2019-2020. The European Commission will also be invited to provide the BoR with information on recent important developments related to the telecommunications market and activities related to the implementation of the new telecommunications regulatory framework.

The MC will also be updated on the progress of budgetary negotiations in the context of the preparation of the Annual and Multiannual Programming of the BEREC Office Activities 2019-2021.

The next meeting of the CN will take place on **14 and 15 February 2018 in Bucharest** and will be hosted by the Romanian National Authority for Management and Regulation in Communications (ANCOM).
