Decision No 01 of 2018 of the Administrative Manager of the BEREC Office on amendment of the Procurement plan for 2018 (D/2018/01)

The Administrative Manager of the BEREC Office,

Having regard to Regulation (EC) No 1211/2009 of the European Parliament and of the Council of 25 November 2009 establishing the Body of European Regulators for Electronic Communications (BEREC) and the Office¹ ('the BEREC Regulation'), and in particular Article 9 (5) thereof, which foresees that the Administrative Manager shall, under the supervision of the Management Committee, take the necessary measures, notably by the adoption of internal administrative instructions and the publication of notices, to ensure the functioning of the Office in accordance with this Regulation;

Having regard to Decision No MC/2014/1 of the Management Committee of the Office of the Body of European Regulators for Electronic Communications on the financial regulation applicable to the BEREC Office in conformity with the framework Financial Regulation for the bodies referred to in Article 208 of Council Regulation (EU, Euratom) No 966/2012 on the Financial Regulation applicable to the general budget of the European Union, and in particular Article 32 (4) thereof, which foresees that the Management Committee may delegate the power to make non-substantial amendments to the annual work programme to the authorizing officer of the Office;

Having regard to Decision No MC/2017/01 of the Management Committee of the Office of the Body of European Regulators for Electronic Communications (BEREC Office) on the adoption of the draft Annual and Multi-annual Programming of the BEREC Office Activities for the period 2018-2020, and in particular Article 2 (1) thereof, which delegates the power to make non-substantial amendments to the annual work programme to the BEREC Office Administrative Manager and Authorising Officer;

Having regard to Annual and Multiannual Programming of the BEREC Office Activities (document MC (17) 109) and in particular to its annex IX 'Procurement Plan for 2018';

Whereas:

- To comply with its mandate and its tasks the BEREC Office identified a list of public procurement procedures to be launched in 2018 and included them in the Annex IX of the Annual and Multi-annual Programming of the BEREC Office Activities for the period 2018-2020;
- (2) The Procurement plan for 2018 has to be amended due to the fact that some details of planned procurement procedures need to be updated and additional procurement

Has adopted the following decision:

Article 1

Article 2

The present Decision shall enter into force on the date of signature.
