

## Decision

# of the Deputy Chairperson of the Management Board appointing the Data Protection Officer of the BEREC Office

# The Deputy Chairperson of the Management Board,

Having regard to Regulation (EU) 2018/1971 of 17 December 2018 of the European Parliament and of the Council establishing the Body of European Regulators for Electronic Communications (BEREC) and the Agency for Support for BEREC (BEREC Office) amending Regulation (EU) 2015/2120 and repealing Regulation (EC) No 1211/2009<sup>1</sup>, and in particular Article 36(4) thereof,

Having regard to Regulation (EU) 2018/1725 of the European Parliament and of the Council of 23 October 2018 on the protection of natural persons with regard to the processing of personal data by the Union institutions, bodies, offices and on the free movement of such data<sup>2</sup>, and repealing Regulation (EC) No 45/2001 and Decision No 1247/2002/EC, and in particular Article 43(1) and (5) thereof,

Having regard to Decision No MC/2012/9 of the BEREC Office Management Committee adopting implementing rules concerning the tasks, duties and powers of the Data Protection Officer pursuant to Article 24 (8) of Regulation (EC) No 45/2001 on the protection of individuals with regard to the processing of personal data by the institutions and bodies of the European Union and on the free movement of such data, and in particular Article 3(1) thereof,

#### Whereas:

- (1) Article 43(1) of Regulation (EU) 2018/1725 requires each Union institution or body to designate a data protection officer.
- (2) Article 43(5) of Regulation (EU) 2018/1725 requires Union institutions and bodies to publish the contact details of the Data Protection Officer and to communicate them to the European Data Protection Supervisor.
- (3) Article 3(1) of Decision No MC/2012/9 requires the Vice-Chair to appoint the Data Protection Officer of the BEREC Office.
- (4) In accordance with Regulation (EU) 2018/1971, the Vice-Chair of the Management Committee is now called the Deputy Chairperson of the Management Board,

### **HAS DECIDED**

# **Article 1**

Mr Marco De Santis is appointed Data Protection Officer of the BEREC Office until 31 May 2022.

This appointment shall be without prejudice to the completion of his probationary period in accordance with Article 14 of the Conditions of Employment of Other Servants of the European Union, laid down by Council Regulation (EEC, Euratom, ECSC) No 259/68<sup>3</sup>.

#### Article 2

The present decision shall be notified to the European Data Protection Supervisor.

### Article 3

Decision MC (16) 91 of the Vice-Chair of the Management Committee of the Office of the Body of European Regulators for Electronic Communications (BEREC Office) is repealed.

#### Article 4

The present decision shall enter into force on 15 June 2019.
