1st meeting of 2020 of the Contact Network established to the Body of European Regulators for Electronic Communications (BEREC) and the Management Board of the BEREC Office

Introduction and Participation

The 1st meeting of the BEREC Contact Network (CN) for 2020 took place on **6 and 7 February 2020 in Tromso** (Norway), kindly hosted by the <u>Norwegian Communications Authority</u> (NKOM). The meeting was chaired by Ola Bergstrom – Director of international Affairs (PTS) and representative of the BEREC Chair 2020.

The meeting was attended by senior representatives of the national regulatory authorities (NRAs) with primary responsibility for overseeing the day-to-day operation of the markets for electronic communications networks and services. NRAs from the EU Member States, from the EEA countries and from the States that are candidates for accession to the EU were also represented. Representatives of the European Commission also attended the meeting.

Main Results of the 1st meeting of the BEREC Contact Network in 2020

The objective of the meeting was to prepare the 42nd ordinary plenary meetings of the BEREC Board of Regulators (BoR) and the Management Board of the BEREC Office (MB), due to take place on 5 to 6 March 2020 in Belgrade. Consequently, the BEREC Contact Network (CN) considered all possible topics to be included in the BoR and MB agendas and concluded the following:
