

**Decision No 03 of 2020**  
**of the Director of the Agency for Support for BEREC on amendment of the**  
**Procurement plan for 2020**  
**(D/2020/03)**

**The Director,**

Having regard to Regulation (EC) No 2018/1971 of the European Parliament and of the Council of 11 December 2018 establishing the Body of European Regulators for Electronic Communications (BEREC) and the Agency for Support for BEREC (BEREC Office), amending Regulation (EU) 2015/2120 and repealing Regulation (EC) No 1211/2009, and in particular Article 20 (7) thereof, which provides that the Director shall, under the supervision of the Management Board, take the necessary measures, notably by the adoption of internal administrative instructions and the publication of notices, to ensure the functioning of the BEREC Office in accordance with this Regulation;

Having regard to Decision No MB/2019/13 of the Management Board of the BEREC Office on the financial regulation applicable to the BEREC Office, and in particular Article 32 (3) thereof, which provides that the Management Board may delegate the power to make non-substantial amendments to the annual work programme to the BEREC Office authorising officer;

Having regard to Decision No MB/2019/03 of the Management Board of the BEREC Office on the adoption of the draft Annual and Multi-Annual Programming of the BEREC Office Activities for the period 2020-2022, and in particular Article 2 thereof, which provides for the delegation of powers to the Director of the BEREC Office to make non-substantial amendments to the annual work programme;

Having regard to Decision No MB/2019/22 of the Management Board of the BEREC Office on the adoption of the updated Single Programming Document of the BEREC Office Activities for the period 2020-2022, and in particular recital (21) thereof, which provides for the delegation of powers to the BEREC Office Authorising Officer to make non-substantial amendments to the annual work programme;

Having regard to the Single Programming Document of the Activities of the BEREC Office for the period 2020-2022, Ref. MB (19) 116, and in particular to its Annex IX 'Procurement Plan';

Whereas:

- (1) To comply with its mandate and its tasks the BEREC Office identified a list of public procurement procedures to be launched in 2020 and included them in the Procurement plan for 2020 forming an integral part of the Single Programming

Document of the Activities of the BEREC Office for the period 2020-2022 as its Annex IX;

- (2) The Procurement plan for 2020 should be amended to update some details of the planned public procurement procedures and due to changed needs to add or remove several public procurement procedures identified during the course of the year 2020;

**Has adopted the following decision:**

**Article 1**

The procurement plan contained in Annex IX of the Single Programming Document of the Activities of the BEREC Office for the period 2020-2022 is replaced by the procurement plan inserted in Annex I of the present Decision.

**Article 2**

The present Decision shall enter into force on the date of its signature. It shall be published on the Agency's website.
