

## Decision No BoR/2021/03 of the Board of Regulators on the BEREC Working Groups

## The Board of Regulators,

HAVING REGARD TO Regulation No 2018/1971 of the European Parliament and of the Council of 11 December 2018 establishing the Body of European Regulators for Electronic Communications (BEREC) and the Agency for Support for BEREC (BEREC Office)<sup>1</sup>, amending Regulation (EU) 2015/2120 and repealing Regulation (EC) No 1211/2009 (Text with EEA relevance) and, in particular Article 13 thereof;

HAVING REGARD TO the Rules of Procedure of the Board of Regulators<sup>2</sup> and, in particular Article 11 thereof;

HAVING REGARD TO the Rules of procedure on the operation of BEREC Working Groups<sup>3</sup> and, in particular Article 1 thereof.

Whereas,

- 1) The work of BEREC may be organised into Working Groups (WGs);
- 2) The Board of Regulators shall create WGs to assist with the performance of the tasks and functions of BEREC;
- The Board of Regulators shall appoint the Chairs of the WGs, representing, where possible, different NRAs;
- The Board of Regulators has created ten WGs and two Ad-hoc WGs and it has appointed all Co-Chairs with Decision BoR/2020/04<sup>4</sup>;
