

Decision No MB/2021/06
of the Management Board of the Agency for Support for BEREC (BEREC Office)
on the designation of two Reporting Officers to appraise the Director of the BEREC Office

The BEREC Office Management Board,

Having regard to Regulation No 31 (EEC), 11 (EAEC), laying down the Staff Regulations of Officials and the Conditions of Employment of Other Servants of the European Economic Community and the European Atomic Energy Community, as amended¹, and in particular Articles 43 of the Staff Regulations, and Article 15 (2) of the Conditions of Employment of Other Servants,

Having regard to Regulation (EU) 2018/1971 of the European Parliament and of the Council of 11 December 2018 establishing the Body of European Regulators for Electronic Communications (BEREC) and the Agency for Support for BEREC (BEREC Office), amending Regulation (EU) 2015/2120 and repealing Regulation (EC) No 1211/2009Text with EEA relevance²,

Having regard to the Decision concerning the appraisal for the Administrative Manager³ of the BEREC Office⁴, and in particular Article 2 (2);

Whereas:

- (1) The Director of the BEREC Office is subject to an annual appraisal exercise for the reference period from 1 January to 31 December 2021;

- (2) The objective of the annual appraisal is the assessment of the efficiency, the competencies and the aspect of conduct in the service of the jobholder;
- (3) The Management Board has to designate at least two Reporting Officers from among the Vice-Chairpersons in order to carry out the appraisal of the jobholder;
- (4) The Reporting Officers cannot be designated to any other functions within the appraisal procedure;
- (5) The Appeal Assessor is the Chairperson of the Management Board and therefore the Vice-Chairperson in charge of the BEREC Office and Incoming Chair (ACM) should not be appointed as a Reporting Officer;
- (6) In case of appeal, the Appeal Assessor should make the final decision on the report of the jobholder after consultation with the Management Board.

HAS ADOPTED THIS DECISION:

Article 1

The Vice-Chairpersons of the Management Board listed below are hereby designated as Reporting Officers to carry out the annual appraisal of the Director for the period from 1 January to 31 December 2021:

- Mr **Dan Sjöblom**, Director General of PTS (Sweden);
- Mr **Jesmond Bugeja**, Acting Chairman of MCA (Malta).

Article 2

The present Decision shall enter into force on the day of its adoption.
