**Applications are invited for the establishment of a reserve list for the post of Facilities Assistant at the Agency for Support for BEREC.**

**1. Agency for Support for BEREC (BEREC Office)**

The BEREC Office has been set up to provide administrative and professional support to BEREC, the Body of European Regulators for Electronic Communications. The BEREC Office is located in Riga, Latvia.

The BEREC Office is an Agency of the European Union (EU) managed by a Director under the supervision of a Management Board composed of the heads of the EU national regulatory authorities (NRAs) in charge of the monitoring of the telecom markets and a European Commission representative.

The BEREC Office is responsible, in particular, for collecting information from NRAs and exchanging and communicating information in relation to the role and tasks of BEREC, disseminating regulatory best practice among NRAs, assisting the Chair of the BEREC Board of Regulators in the preparation of his/her work, and setting up and providing support to expert working groups.

The Staff Regulations of Officials of European Communities, the Conditions of employment of other servants of the European Communities (CEOS) and the rules adopted jointly by the EU institutions for the purpose of applying these Staff Regulations and CEOS apply to the staff of the BEREC Office.

## **2. The post**

The job holder will be responsible, among others, for the following tasks grouped in four functions:

### 2.1. Building and facility maintenance:

- Supervise and coordinate facilities management contractor, incl. regular meetings with the contractor to discuss scheduled and ad hoc works required;
- Place orders and supervise works via the contractor's helpdesk;
- In-depth check of and sign off on contractor's invoices against work schedule, contract stipulations and work docket;
- Discuss and agree with contractor about changes required to the contract or its conditions;
- Close following-up of available budget and its consumption on scheduled and ad hoc services and input to budget forecast meetings;
- Draft new tender specifications for new procurement procedures and processing of procurement files.

### 2.2. Buildings and supplies (incl. logistics):

- Supervise and coordinate the provision of logistics services by the respective contractors, incl. regular meetings with the contractor to discuss the quality and schedule of deliveries;
- Place orders and supervise delivery of the required goods and services via the respective contractor's channels;
- In-depth check of and sign off on contractor's invoices against work schedule, contract conditions, etc.;
- Discuss and agree with contractor about changes required to the contract or its conditions, etc.;

- Operational facilities work such as small repairs, office / furniture moves, inventory registration and control, garden works;
- Plan and implement measures for sustainability and environmental management of facilities as well as in relation to EMAS or similar certification.

### 2.3. Budget, finance, contracts and accounting:

- Contribute to effective planning and execution of projects in the main area of work of the jobholder, including through Service Level Agreements/ Memoranda of Understanding, inter-institutional contracts or through contracts signed by the BEREK Office;
- Assist in preparation of documents and signing agreements with the Commission services or other bodies of the EU for provision of goods and services (including through inter-institutional procurement procedures);
- Contribute to procurement procedures organised by the BEREK Office in the main areas of work;
- Ensure contract management in the main areas of work, monitor performance of the contractors and enhance contract outcomes;
- Ensure good planning, consumption monitoring and reporting of available budget for building and movable property in line with the principle of activity-based budget management (ABM);
- Provide input to the year-end closure procedure in planning the amounts to be carried-over and determining the cut-off entries in the area of responsibility.

### 2.4. Administrative assistance:

- Help in keeping the filing plan and list of files of the BEREK and BEREK Office in the area of responsibility up to date;
- Register and file documents in the BEREK Office document management systems;
- Keep the facility management files in order in line with existing rules, prepare them for audits and ensure a proper organisation of the documentation for audit and audit follow-up;
- Support the implementation of the internal control framework and participating in the risk management at the BEREK Office.

The above tasks and responsibilities will be conducted in the English language.

The jobholder will work under the supervision of his/her line manager at the BEREK Office located in Riga, Latvia and may be assigned other duties appropriate to the grade in the interest of the service.

### 3. Eligibility criteria

Candidates will be eligible for this selection procedure if they fulfil the following formal criteria at the time of the application deadline:

- 3.1. Be a national of a Member State of the European Union (EU) and enjoy his or her full rights as a citizen;
- 3.2. Have fulfilled any obligations imposed by applicable laws concerning military service;
- 3.3. Be physically fit to perform the duties linked to the post<sup>1</sup>;
- 3.4. Produce the appropriate character references as to suitability for the performance of the duties<sup>2</sup>;
- 3.5. Languages: Have a thorough knowledge of one of the official EU languages and a satisfactory knowledge of a second EU language to the extent necessary for the performance of his/her duties;
- 3.6. Qualifications and work experience:
  - a. Have a level of post-secondary education attested by a diploma<sup>3</sup>; or
  - b. Have a level of secondary education attested by a diploma giving access to post-secondary education, and appropriate professional experience of at least three years.

### 4. Selection criteria

If the eligibility criteria set out in the section “Eligibility criteria” are met, the candidates’ application forms, CVs and motivation letters will be evaluated on the basis of the selection criteria below. The most suitable candidates will be invited to an interview and written test.

When filling in the application form, candidates are expected to include elements that demonstrate that their profile matches the requirements below.

#### 4.1. Essential:

- 4.1.1. At least 3 years of relevant professional experience in a similar role<sup>4</sup>;

- 4.1.2. Experience or knowledge in building and facility maintenance activities;
- 4.1.3. Experience or knowledge in budget, procurement and contract management for building and facility maintenance activities;
- 4.1.4. Thorough knowledge of written and spoken English.<sup>5</sup>

#### 4.2. Advantageous:

- a. Knowledge in the area of procurement and contract management under the EU Financial Regulation<sup>6</sup>;
- b. Experience in engaging, supervising and coordinating contractors;
- c. Good analytical, problem-solving and organisational skills as well as motivation and interpersonal skills;
- d. Experience in an international or multicultural environment.

#### 4.3. Evaluation during interviewing and written test process

Candidates invited to the interview and written test will be evaluated based on their professional and personal competencies, as well as their knowledge of English as a working language and their motivation and commitment to work for the BEREC Office in Latvia.

### 5. Stages in the selection procedure

The BEREC Office sets up a Selection Committee. This Committee will make a comparative assessment of all eligible applications, and identify a number of candidates whose profiles best match the selection criteria listed above. These candidates will be invited for a written test and an interview with the Selection Committee.

The selection procedure will be organised in accordance with the following steps:

#### 5.1. Admission to the selection procedure

After the deadline for applications, the complete applications submitted (application forms, CVs and motivation letters) will be checked against the eligibility criteria. Only eligible applications will be then assessed against the selection criteria (essential and advantageous).

#### 5.2. Assessment of eligible applications

The Selection Committee will analyse the motivation letters, together with the application forms and the CVs of eligible applicants with reference to the elements indicated in the selection criteria section (essential and advantageous). In addition, the Selection Committee will assess the motivation and the overall suitability of each eligible application on the basis of the requirements of the post.

#### 5.3. Interview and written test

Upon completion of the assessment of eligible applications, the most suitable candidates will be invited for a written test and an interview. The maximum total number of candidates invited to attend the interview and written test will be 10.<sup>7</sup> The interview and written test will take place at the BEREK Office in Riga, Latvia.

Candidates are kindly invited to indicate in their application any special arrangements that may be required, if invited to attend the written test and interview.

The interview will aim to assess the suitability of the candidates to perform their duties, their professional knowledge, their skills and competencies relevant to the post and their motivation. The interview shall cover an analysis of the language abilities and the personal and professional competences of each applicant. The interview will be held in English. Candidates with English as their mother tongue will be tested in another official EU language to check that the eligibility criteria is met (i.e. satisfactory knowledge of a second official EU language).

The written test will be in English. It will be related to the tasks and responsibilities related to the post, and be designed to test candidates' ability to communicate in written English, and their job-related knowledge and competences.

The content of the questions asked during the interviews will be set in accordance with the level and profile of the position advertised.

The Selection Committee will propose a maximum of 5<sup>8</sup> candidates with the highest scores achieved in the interview and written test for placement on the reserve list.

#### 5.4. Establishment of a reserve list

On the basis of the outcome of the interviews and written tests, the authority authorised to conclude contracts of employment may draw up a reserve list of maximum 5<sup>9</sup> candidates.

The reserve list will be valid until 31 December 2022. Its validity may be extended by the authority authorised to conclude contracts of employment. Inclusion on a reserve list does not imply any entitlement to employment in the BEREK Office. Moreover, recruitment will be subject to budget availability.

#### **6. Possible job offer(s), verification of documents and scrutiny**

If a post in the relevant function group and job field related to the current call for expression of interest becomes vacant, a job may be offered to a suitable candidate<sup>10</sup>.

The information provided in the applications of the successful candidates will be checked against the supporting documents to confirm its accuracy and eligibility.

If, at any stage in the procedure, it is discovered that the information given in an application has been knowingly falsified, the candidate will be disqualified from the selection process.

Candidates will also be disqualified if they:

- do not meet all eligibility criteria;
- do not provide all the required supporting documents, including to substantiate the facts and statements in their applications.

#### **7. Conditions of employment**

The Facilities Assistant will be appointed by the authority authorised to conclude contracts of employment as a contract agent in function group III pursuant to Article 3a of the Conditions of employment of other servants of the European Communities for a period of three years. The authority authorised to conclude contracts of employment may renew the contract according to the modalities indicated in the relevant general implementing rules valid at the BEREK Office.

The period of engagement will not in any case exceed the lifetime of the BEREK Office.

#### **8. Application procedure**

For their applications to be valid, candidates must submit:

**Applicants are explicitly requested to highlight and give a brief account of their experience and expertise relevant to the job and the start and end dates of employment contracts. Applicants are invited to indicate, apart from the duration of studies, the legal length of the diplomas that they hold.**

**Applications will not be assessed if the dossier is incomplete or submitted after the deadline.**

Supporting documents (e.g. certified copies of degrees/diplomas, references, proof of experience, etc.) should not be sent at this point but must be submitted at a later stage of the procedure, when requested.

Candidates are asked to report any potential change of address in writing without delay to the address above.

### **Closing date for applications**

Applications must be sent by email. The deadline is **22/07/2022 at 12:00 (midday) Riga time** (11:00 a.m. Central European Time). The Agency strongly advises candidates not to wait until the last few days before the deadline to apply. It is the sole responsibility of each applicant to submit his/her completed application by the deadline for submission. Any information or documentation provided after the deadline will not be taken into account.

### **Approximate timetable**

The selection process may take several months; information will be released at the end of each stage.

## **9. Independence and declaration of interests**

The Facilities Assistant may be required to make a declaration of commitment to act independently in the public interest and to make a declaration in relation to any interests that may be considered prejudicial to his/her independence. Candidates must confirm their willingness to do so in their application.
