

#### **PRIVACY NOTICE**

# for processing of personal data in the context of BEREC and the BEREC Office public events

The Agency for support for BEREC (BEREC Office) processes the personal data of a natural person in compliance with Regulation 2018/1725 on the protection of natural persons with regard to the processing of personal data by the Union institutions, bodies, offices and agencies and on the free movement of such data, and repealing Regulation (EC) No 45/2001 and Decision No 1247/2002/EC.

This privacy notice explains the BEREC Office's policies and practices regarding its collection and use of your personal data, and sets forth your privacy rights. We recognise that information privacy is an ongoing responsibility, and we will update this notice, where necessary.

# 1. What is the purpose and the legal basis for collecting and processing your personal data?

The purpose of the processing of personal data is the organisation and management of **BEREC and the BEREC Office public events**,,including:

- Registration of participants interested in the event;
- Management of the lists of invitations and participants;
- Management of access control to the event venue;
- Distribution of information, reports, publications and other event documents among invitees and registered participants;
- Arrangement of event follow-up actions;
- Sharing event content (e.g. photos, audiovisual recording or livestreaming) via communications channels (e.g. social media and websites) and internal streaming platforms.

The organization of **BEREC and the BEREC Office public events** is necessary for the performance of the Agency's tasks carried out in the public interest as required by Regulation (EC) No 2018/1971. Therefore, the processing is lawful according to Article 5(a) of Regulation 2018/1725. In particular, the processing is lawful as provided for under the following legal basis: Articles 11 and 18 of Regulation (EU) 2018/1971, Art.4 and 12 of the Rules of Procedure of the Board of Regulators BoR (19) 58; Art. 5 of the Rules of Procedure of the Management Board of the BEREC Office MB (19) 95 Rev.1, BEREC Work Programmes and BEREC Office Programming Documents.

In addition, processing of the photos and videos during the public events is lawful based on Article 5(1)(d) of the Regulation, i.e. on data subjects' consent.



#### 2. What personal data do we collect?

The BEREC Office regularly organises **BEREC** and the **BEREC** Office public events. These events and meetings may be held in Riga, Brussels and in any other European venue.

Before and during these events, the Agency may process:

- Contact details of participants registered to the event: first and last name, organisation, position, email address, phone number;
- Identity/passport number and validity, nationality, country of residence, gender, date of birth, any data necessary for access control purposes to the event venue (if applicable);
- Dietary requirements and special assistance, when applicable, processed in a secured manner for the sole purpose of accommodating special needs or dietary requests;
- Photos, audio or video recording and livestreaming of speakers, participants or organisers, as well as written exchanges between the meeting participants (chat function in a videoconference meeting);
- Transcripts of the event.

Participants may be required to enter their registration data via a dedicated online form available at the BEREC website event section.

#### Video and web-conferencing (VTC)

Video and Web-conferencing systems may be used, when personal presence at the **BEREC and the BEREC Office public events** is not feasible. The Agency may, therefore, use Video-conferencing systems (including, but not limited to Webex, MS Teams) to enable remote participation in its events and meetings.

When participants are invited to register for a meeting held via video-conference they can be requested to indicate their contact details, their role during the event, the name of their organization and any questions/interventions they intend to make during the event.

# Photographing, recording and streaming of event sessions

The BEREC Office may take photos and video recording of the event and publish them on its website and other social media channels (Twitter, LinkedIn and YouTube).

In addition, the BEREC Office may broadcast the event publicly via dedicated livestreaming platform.

The BEREC Office will process photos and audio or video recording only upon your consent.

Please note that, if a person do not wish to appear in photos or audio-video recording/live streaming, it has to inform the event organiser at communications@berec.europa.eu

We will make all possible arrangements to respect your choice.



#### 3. Who has access to your personal data and to whom is it disclosed?

The data collected will be processed internally by the BEREC Office staff within the team responsible for the event's organisation, and (when applicable) by dedicated service provider staff supporting the meeting/event.

Access to all personal data is granted on a need-to-know basis to recipients defined by the BEREC Office.

The recipients typically are:

#### Within the BEREC Office:

- Staff within the organising team;
- ICT staff supporting the infrastructure of the meeting (audio-visual equipment, streaming, etc.).

#### Outside the BEREC Office:

- When applicable, service providers for organisational purposes, who are contractually bound to process personal data on behalf of the BEREC Office, as well as personnel of the NRA/entity supporting the meeting organization;
- General public only for event outputs (documents, agendas, presentations, event transcripts, audio-video recording) that may be published on the BEREC website or on other online communication channels.

### 4. How long are your personal data kept?

The BEREC Office only keeps your personal data for the time necessary to fulfil the purpose of collection or further processing, namely for organising the meeting and any follow-up actions as necessary with regard to the purpose(s) of the meeting. All personal data will be deleted from databases 1 year after the last action in relation to the meeting.

Specific retention applies to:

- <u>Final participant list serving as proof for reimbursement</u>: it will be kept for 7 years after the end of the specific event;
- Identification data for accessing the meeting venue:
  - For events in the BEREC Office premises, personal data will remain in the visitor register for maximum 6 months;
  - For events in other venues, the meeting co-organiser will delete these data at the latest ten working days after the event;
- Sound recordings of events not intended for publication: will be deleted after the final report of the event is delivered;
- Edited audio and video materials, presentations, transcript and photographs intended for publication: will be kept on the BEREC website, BEREC social media accounts (YouTube, Twitter, LinkedIn) and on internal streaming platforms as long as their content is useful for the purpose of the meeting/event.

#### 5. What are your rights?

You have the right to request from the controller <u>access</u> to and <u>rectification</u> or <u>erasure</u> of your personal data or restriction of processing.



You also have the right to object to processing of personal data.

You have the right to withdraw your consent for the BEREC Office to process your personal data at any time. The controller shall provide information on action taken on a request within one month of receipt of the request. That period may be extended by two further months, where necessary, taking into account the complexity and number of the requests.

# 6. Who is the data controller and how to exercise your rights?

The BEREC Office shall exercise the tasks of the data controller for the purpose of these processing operations.
