Mr. Konstantinos MASSELOS, BEREC Chair 2023 (EETT, Greece)



Konstantinos Masselos is the BEREC Chair 2023 and the President of the Hellenic Telecommunications and Post Commission (EETT). In 2006, he joined the University of Peloponnese as a Professor in Computing Systems Design in the Department of Informatics and Telecommunications. He served as Rector of the above mentioned university from 2012 to 2017. Between 2005 and 2008, he was Lecturer in the Department of Electrical and Electronic Engineering at Imperial College London. Also, during the period 2010-2016, he was an Honorary

Lecturer in that same Department. From 2001 to 2004, he worked in the Greek electronic communications industry. Prof. Masselos has been involved in several research and development projects and has a long consulting experience in industry and public organisations. Since 2005, he has regularly been involved as an expert in various European Commission units. He was a member of the Scientific Committee of European Cooperation in Science and Technology (COST) from 2015 to 2017. He has authored over 120 papers in international journals and conferences.

Ms. Laura BALKE, Policy Officer in the Cloud and Software Unit, (DG CNECT)



Laura Balke is the Policy Officer responsible for the Data Act in the Cloud and Software Unit of the European Commission's Directorate-General for Communications Networks, Content and Technology (DG CNECT). Outside of DG CNECT, Ms Balke has also worked in DG TRADE's unit for the USA and Canada and as a policy analyst in the Directorate-General for Agriculture and Rural Development. Prior to joining the European Commission, Ms Balke worked for Bitkom, Germany's digital association, and in the Brussels office of Siemens. A graduate of Dresden University of Technology and the College of Europe in Bruges, Ms Balke has used her

studies to specialize on EU digital policy.

Prof. Daniel Schnurr, research fellow at CERRE and University of Regensburg



Daniel Schnurr is a professor of Information Systems and holds the Chair of Machine Learning and Uncertainty Quantification at the University of Regensburg. He is also a Research Fellow of the Centre on Regulation in Europe (CERRE), a Brussels-based think tank. Previously, he was head of the research group Data Policies at the University of Passau. He received his Ph.D. in Information Systems from the Karlsruhe Institute of Technology in 2016, where he previously studied Information Engineering and Management (B.Sc. & M.Sc.).

In his research, Daniel Schnurr addresses the technical, economic, and societal implications of new machine learning methods and data as a crucial competitive factor

and driver of innovation in digital markets. His research articles have been published in leading journals in Information Systems and Economics. His current research focuses on the role of artificial intelligence for competition, privacy and data sharing in digital markets, as well as regulation of AI and the data economy.
