

Decision No MB/2024/01

of the Management Board of the Agency for Support for BEREC ('the BEREC Office') on the appointment of the Co-Chairs of the Expert Networking Groups

The Management Board of the BEREC Office;

Having regard to Regulation (EU) 2018/1971 of the European Parliament and of the Council of 11 December 2018 establishing the Body of European Regulators for Electronic Communications (BEREC) and the Agency for Support for BEREC ('BEREC Office'), amending Regulation (EU) 2015/2120 and repealing Regulation (EC) No 1211/2009¹, and in particular Articles 5;

Having regard to Rules of Procedure of the Management Board of the BEREC Office², and in particular to Article 12 thereof;

Having regard to the Rules of Procedure on the operation of Expert Networking Groups³, and in particular Article 2 thereof;

Having regard to Single Programming Document of the Activities of the Agency for Support for BEREC ('BEREC Office') for the period 2024-2026⁴;

Whereas,

- 1) The Management Board of the BEREC Office may decide to create Expert Networking Groups (ENG) to deliver expertise on specific matters requested by the BEREC Office;
- 2) Two Co-Chairs appointed by the Management Board of the BEREC Office shall lead each ENG;
- 3) Each ENG shall be composed of members appointed by the NRAs according to specific criteria depending on the relevant area of expertise;
- 4) With the adoption of the Single Programming Document of the Activities of the Agency for Support for BEREC ('BEREC Office') for the period 2024-2026 the Management Board has created three Expert Networking Groups;

- 5) The Management Board of the BEREC Office shall approve the decision that appoints the Co-Chairs of the Expert Networking Groups.

HAS DECIDED:

Article 1

The following candidates are appointed as the Expert Networking Groups Co-Chairs for the period of 2 years (until 31 December 2025):

- a) For ENG for ICT:
Co-Chair: Mirko Pellegrino (AGCOM),
Co-Chair: Teodor Ivanov (BEREC Office).

- b) For ENG for Communications:
Co-Chair: Paola Calestani (AGCOM),
Co-Chair: Catalina Dragomir (ANCOM).

Article 2

This decision shall enter into force on the day of its adoption by the Management Board of the BEREC Office.
